

# Agreement for Services

This agreement constitutes a "good faith" agreement regarding services rendered to the undersigned (hereafter referred to as "the student"), by DeepWater Music LLC (here after referred to as "the teacher").

## Services

Students shall receive one scheduled lesson time block per week. Lessons will be 30 minutes in duration unless otherwise specified.

## Lesson Cancellation / Rescheduling

In the event of a lesson cancellation by a student or teacher, the lesson may be made up at the teacher's discretion. Non-emergent cancellations will be communicated in person, by phone, (715-363-2876) or email ([aaron@deepwatermusic.net](mailto:aaron@deepwatermusic.net)) at least SEVEN days in advance. Such absences may be made up at a later time within two weeks of the current session. A maximum of 2 make up lessons may be carried concurrently. Make up lessons may be private lessons or group lessons at the teacher's discretion. All tuition and fees are nonrefundable.

## Commitment/duration

Commitment is for the minimum of one session as outlined by the teacher's current calendar. The students who begin mid semester will automatically enroll in the successive semester as well, and pay a prorated rate for the current semester. The student may discontinue study at the end of a semester with no further financial obligation if giving the teacher three weeks prior notice of intent. Discontinuation without such notice or cancellation during an established semester will be subject to a cancellation fee of no less than \$80. Failure to pay as agreed will result in default-status with DeepWater Music, and disqualify the student from monthly payment plans for future enrollment. This agreement shall be in force until canceled, and automatically renew at the tuition of each new semester.

## Liability

The student and/or guardian agree to hold all individual instructors, Deepwater music LLC, and or the hosting facility/ organization without fault in the event of injury or harm incurred in the course of lessons, performances, or other related activity.

## Materials

Such materials as used by the student shall be the financial obligation of the student. This includes, but is not limited to: books, CDs, recordable media, and music accessories.

## Non-distribution agreement

Music arrangements, written materials, and recordings provided by the teacher to the student are for educational purposes only. The student agrees not to sell, duplicate, or distribute such materials in a commercial or noncommercial manner without express, written consent of DeepWater Music.
